We are often reluctant to impose parking restrictions in residential areas as it is usually local people parking and causing the obstruction, this often means there may be objections to the installation of a restriction and that the problem won't be removed, just moved; in this case probably to outside number 2! I would advocate you and the PC review this location and the cause of the problem closely before considering imposing DYL's. It may set a precedent that will be difficult to maintain throughout the community, there are similarly narrow sections of Woodland Road, Old Road, Moreleigh Road etc. However, I have drawn up a plan of the location below using approximately 13m of DYL. Please can you circulate to ensure it is what is wanted by the PC and residents after which we can add it to the HATOC list.


I write with regard to the email below regarding an obstruction being caused by parking as described, outside No 1 Pack's Close Harbertonford.
